

## 2023 ANNUAL REPORT FOR THE INDIANA SOCIETY FOR HEALTHCARE RISK MANAGEMENT

## Dear Membership,

This has been another great year for our organization! We have experienced an 13% increase in membership as well as new sponsorship with Radiological Care Services and Gregory and Appel. We continue to work towards growth in both areas in the future. Over the last year, ISHRM's partnership transitioned from SociallySeasoned, LLC, a digital marketing firm, to AdLabs due to the sale of SociallySeasoned LLC. This service is used to update our <u>website</u>. The costs associated with the service remain unchanged with this transition. The Board also sent letters to 100 healthcare organizations with information on ISHRM membership and conference opportunities. These letters did result in several additional memberships and conference attendees.
